Selection in to the Order of the Arrow is a privilege, not a right. Selection and induction of an adult Scouter should take place only when the adult's job in Scouting will make the Order of the Arrow membership more meaningful in the lives of the youth membership. It must not be for the purpose of adult recognition.

Each year, upon holding a troop, crew, ship, or team election for youth which results in at least one youth candidate being elected, the unit committee may recommend one registered adult to the lodge selection committee. Please refer to the **Adult Candidate Qualifications and Guidelines for Selection** instruction sheet for the number of adults qualified for selection. One form must be completed for each qualifying candidate.

Selection of an adult is based upon ability to perform the necessary functions and not as an honor or recognition of service, including current or prior achievement and position. 1. Camping Requirement

The camping requirement, which applies to youth candidates, applies to adults. The adult must have experienced fifteen days and nights of Boy Scout camping **during the two-year period before the nomination**. The fifteen days and nights must include one, but no more than one, long-term camp consisting of six consecutive days and 5 nights of long-term camping, approved and under the auspices and standards of the Boy Scouts of America. The balance of camping must be overnight, weekend or other short-term camping.
